What is a Formative Assessment?

Formative assessment is a planned, ongoing process used by students and teachers during learning and teaching to elicit evidence of student learning. In a learning partnership, students and teacher use the evidence to improve students' understanding of intended curricular learning outcomes and support them to become self-directed learners. High quality formative practices are inseparable from instruction and are used to provide in the moment feedback to students and for teachers to gain insight into student thinking so they can adjust instruction to best meet students' learning needs.

Why is it important?

The primary purpose of formative assessment is to provide students feedback about their learning. These practices empower teachers with a deeper understanding of student learning and needs, informing appropriate instructional decision-making to meet the needs of students in relation to learning goals. Formative assessment can occur through informal checks during the teaching learning process, or integrated question sets in lesson plans, all with the aim of making student thinking visible.

How does this connect to reentry in fall 2020?

As students reenter schools (remotely, in-person, or hybrid) in the fall, they will arrive with varying degrees of learning and instructional needs. While there is no one-size-fits-all solution to identifying and addressing students' needs in the wake of these disruptions, formative assessment practices, which are embedded in strong instructional practices, serve to provide evidence of what students know and can be used to adapt instruction accordingly. Further, by regularly gathering evidence of student understanding and misconceptions as part of instruction, teachers may use formative assessment practices to plan differentiated instruction, a necessary framework to support students upon reentry.

What is available to New Mexico schools?

NM PED recognizes that teachers are regularly engaged in formative assessment practices within their classroom. These formal or informal checks on understanding happen in the moment and inform instructional next steps. However, given the need for high-quality, NM content standards-aligned tools in the wake of significant learning loss, NM PED is providing Cognia formative assessment resources to all NM schools.

The resources are designed to help teachers and learners identify misconceptions, define success, and adjust instruction. They include:

- Dozens of pre-assembled, high quality questions ("item sets") that pinpoint learning targets.
 - Support materials that provide detailed information about targeted standards, item complexity, and specific skills addressed.
 - "Distractor rationales" for multiple-choice items that identify the misconceptions in each incorrect option.
 - Scoring guides to help probe students' understanding using items that require students to construct their responses

Additionally, Cognia Formative assessments provide:

- Reading, mathematics, and STEM resources for grades 3–8
- Items grouped in sets that take 10–15 minutes
- Information for teachers, including blueprints and scoring information
- Ability for teachers to select individual items or create their own sets
- Instant scoring for multiple-choice items
