

Safe/Troubled Child Alert Protocol

Vendors contact PED Assessment Coordinator (PED AC)

 \mathcal{D}



PED AC downloads the trouble child alerts from vendor secured portal and places it in the districts <u>SharePoint</u> folder.

PED AC calls the District Test Coordinator (DTC) and sends an email with the SharePoint URL.

DTC will report to PED AC about the status of wellness check without needing to provide additional information.



The PED AC will contact CYFD at 1-855-333-SAFE [7233] or #SAFE **DTC** notifies principal, counselor, or other personnel at the school to do a wellness check.
