Are there open-ended questions in the interim? If so, who will score them?	There are no open-ended questions in the interim.
How long and how many tests are on the interim assessments?	For interim assessments, there are 3 forms administered at three points during the school year.
For iMSSA BOY, MOY, EOY, is there a way to get a breakdown of student performance on the standards assessed?	For iMSSA, student performance is reported at the domain level. We will be providing an item analysis report this year to help bridge the student results to standards and assist with classroom instruction.  Look for a training session on that later this month.

Will we be given access to report on the portal later?	Current users (depending on permissions) have access to reporting in the portal. If you believe you should have access and do not, please contact the Help Desk at 877-676-6722.
Just to clarify. You can use the Updated Kiosk to administer iMSSA?	Yes, the interim assessment can be administered in kiosk or web-browser. Regardless of that method they all must be administered in school.
So, does that mean new students who transfer have to be added one at a time?	If the student was uploaded by another LEA, then the student would just need to be transferred into your district in the portal using the enrollment

	transfer feature. If the student is not in the NM Portal, then you will need to add the student manually if the Pre-ID window is closed.
Will the student information be uploaded from STARs, or will I have to upload the students?	For iMSSA districts will upload students. This can be done in bulk during the pre-id upload windows, or manually outside of those windows. The current pre-id window for BOY is open until 8/13/2021. There will be another one for MOY from 11/15-12/3/2021. The dates for EOY and summative are still being determined.

Also, I am technically ITC (not DTC) but as an administrator, in the district, I tend to assist as STC/DTC. Can the DTC give me multiple roles? I have had two accounts in years past and will continue to do so if needed.	A user can only have 1 role in the portal at this time. So, you will either need the role with the highest access assigned to your account to perform your tasks or you can continue to use two different accounts. You can have multiple schools assigned to your account if needed.

I'm a DTC. If I create New User with a RAO role, will he or she be able to access reports on the portal?	The user will only have access to reporting on the portal landing page. They would click on reporting and be directed to the reports in Data Interaction (DI).
Can you assign a TA after a session has been administered - we have SPED students who may be tested in small groups and may not necessarily test with their regular teacher but will need to be visible to the regular teacher (TA) after testing is complete?	The best option at the moment will be for the STC/DTC to log into the reporting portal, print out the Individual Student Report for that student, and share it with the regular teacher. We are working on possible other solutions and will be able to expand on this more at the reporting training on Tuesday, August 10.

We are not a K5 Plus school. We are planning on administering BOY and MOY but would prefer not to give EOY, is that ok?	Appreciate the question. As it is optional (since you are not a K5+ school), you are able to use it how you'd like. I highly recommend that if you are only going to do 2/3, to do the BOY and the MOY (since you can see growth on the NM MSSA as a summative). Hope this answered your question.
Can we use the same classes and assign both interim and summative assessments?	Yes, the classes can be used for all assessments.
How much time should we allot for the interim assessments?
