# 1. Overview

## 1.1 About This Manual

This manual outlines the steps to be followed before, during, and after administration of the spring 2025 New Mexico Measures of Student Success and Achievement (NM-MSSA). Understanding of and compliance with each of these steps is vital for a successful administration. Please read this manual to become familiar with the test administration procedures before testing begins.

## 1.2 About the Tests

The 2025 NM-MSSA assessment will be administered in either computer-based test (CBT) or paper-based test (PBT) format. In accordance with PED policy, a student must have a need to test on paper documented in their IEP in order to test on paper. English Language Arts (ELA) and Spanish Language Arts (SLA) assessments will focus on reading skills related to the comprehension and analysis of texts, the analysis of pieces of writing and knowledge of standard language conventions, and the production of writing while using standard language conventions. Mathematics assessments will focus on applying skills and concepts and understanding multi-step problems that require abstract reasoning and modeling real-world problems, precision, perseverance, and strategic use of tools. In both content areas, students will demonstrate their acquired skills and knowledge by answering items of various types, such as selected-response items, multiple-select items, evidence-based selected-response items, and open-response items.

Each NM-MSSA assessment comprises two sessions. During administration of Mathematics assessments, calculators are not allowed during the first session of the test, but all students are allowed to use calculators during the second session. All formulas that a student needs to complete the assessment are included within the question. No formula sheet will be provided or allowed during the assessment. For more information regarding calculator use in Mathematics, refer to [Appendix E](#). Refer to [section 2.2.2](#) for additional information about the number of sessions for each assessment.

## 1.3 Test Administrator Responsibilities

Test administrators (TAs) are vital to the success of the NM-MSSA. For this reason, the instructions given in this manual must be followed exactly by each TA.

**The TA must be a PED licensed educator who has received training from the School Test Coordinator (STC) or District Test Coordinator (DTC).** If schools require additional proctors to administer the NM-MSSA, other staff members (who have received training and have signed the PED Confidentiality Agreement) may be used to provide one-on-one accommodations. Please contact PED with questions.

The TA's primary responsibilities include

- reading this manual,
- meeting with the STC to review the testing schedule,
- preparing the test environment so that nothing is visible that would provide aid in answering any of the questions on the test,
- ensuring a standardized test environment by following the directions and scripts in this manual,
- testing the assigned group(s) of students according to the instructions in this manual, and
- overseeing PBT materials during test administration and reporting any missing test booklets or answer documents to the STC.

A TA task checklist is provided in [Appendix A](#).

## 2. Administration Policies

### 2.1 Security Guidelines

#### 2.1.1 Security of Test Materials

The New Mexico Statewide Assessment Program requires that the NM-MSSA receives the highest level of test security and accountability. The security of NM-MSSA materials must be maintained before, during, and after the test administration. Please follow the guidelines in this manual for distributing, collecting, and returning these materials. Be sure that all testing personnel have access to a central, locked storage space for the safekeeping of test materials until the materials are returned to Cognia.

To maintain the validity of the tests administered in the statewide assessment program, keeping all test questions secure is absolutely necessary. If security is breached or compromised, the assessment results may not be valid. If one student, school, or district has advantages not awarded to another, the test administration is no longer standardized and loses the important distinction of being appropriate for program accountability.

TAs must follow these security guidelines before, during, and after testing:

- Receive training on test security and administration by the STC or the DTC.
- Complete the New Mexico PED Confidentiality Agreement and return it to the STC. (The Confidentiality Agreement form is available on the PED website—see link in [Appendix B](#).)
- Follow the testing schedule established by your school.
- Ensure that you are not assigned to a classroom in which a relative is being tested.
- Carry out standard examination procedures.
- Ensure secure test materials are stored in a central and locked, secure area when not in use.
- Use the Security Checklist or a similar tracking tool daily, as provided by the STC, during test administration to check in and check out all test materials. See [Appendix C](#).
- Report any possible breaches of security to the STC immediately.
  - › Examples of security breaches include, but are not limited to,
    - improper handling of test materials, such as
      - someone reproducing any student responses;
      - allowing any unauthorized access to test materials before, during, or after testing;
      - leaving test materials (including computers being used for computer-based testing) unsecured when the TA or a proctor is not in the classroom; and
      - allowing students to take photos of test materials or share questions and/or answers via text or chat functions on their cell phones.
    - improper test administration procedures, such as
      - coaching students during testing;
      - altering student responses in any way; or
      - stray mark cleanup, including but not limited to, erasing double-marked, lightly erased, or lightly marked answers.

**School and district staff members are prohibited from studying or discussing online test questions in any manner, either among themselves or with students, before, during, or after testing.**

### ***What Is Considered Secure Material?***

For PBT administration,

- test booklets, answer documents, and scratch paper written on by students are secure.
- students may be provided with scratch paper for their use on the test. All scratch paper must be collected and securely shredded at the school immediately following testing.

For CBT administration,

- the Student Login Tickets, scratch paper written on by students, and human-reader scripts (if applicable) are secure.
- students may be provided with scratch paper for their use on the test. All scratch paper must be collected and securely shredded at the school immediately following testing.

It is important that students are not provided access to secure test materials except during test administration. Early exposure to secure test materials will invalidate the data results for the student's test.

Manuals are not considered secure, but should be carefully disposed of after testing to ensure that old versions are not being used during future administrations.

### ***Reproduction or Unauthorized Distribution of Secure Materials***

Unauthorized reproduction of test materials is a violation of the Federal Copyright Act and of section 6.10.7 of the New Mexico Administrative Code, which addresses test security and administration of the New Mexico Statewide Assessment Program. One requirement of this regulation is that signs be posted near school copy machines before and during the test administration window to notify individuals that NM-MSSA materials may not be reproduced in any fashion, including paraphrasing.

The test materials may not be provided to any persons not coordinating and administering the test or being tested.

Test questions may not be taught in part or in whole before, during, or after testing. Test questions may only be presented to students during the test administration period via the standardized procedures described in this manual and the *Test Coordinator's Manual* (TCM). The answers to questions may not be provided to students by any method (e.g., orally or in writing). Answers to test questions may not be deleted or altered by anyone except the student while taking the test. Reading test questions aloud to students, except in instances specified in this manual, is only permitted if the student qualifies for such an accommodation. Please see the list of prohibited activities in [section 2.1.3](#). Please contact PED with specific questions regarding a secure, standardized testing environment.

## **2.1.2 Electronic Device Policy**

Under PED's direction, schools must enforce a strict electronic device policy during standardized testing to maintain test security. This policy applies to administrations of all New Mexico state assessments. If parents or family members need to contact a student during testing days, they may call the school office.

### ***What Is Considered an Electronic Device?***

The term electronic device includes any personal, non-educational device with an on-off switch excepting medical equipment. This includes the following common devices:

- cell phones
- smart phones
- MP3 players, iPods, or other music players
- iPads, tablets, laptops, or other computers
- smart watches

## ***Before Testing Begins***

### **Schools must clearly inform students that**

- **bringing an electronic device into the testing area violates school and state policy, and**
- **violation of this policy is grounds for confiscation and a search of the device.**

The following procedures must be implemented when test materials are distributed:

- Electronic devices must be turned completely off. They may not be on “silent” or “vibrate” modes.
- Unless a student has a medical need and has an approved Non-Standard Accommodations request on file, electronic devices may not be on a student’s body. This includes in pockets or otherwise stored in clothing.
- Electronic devices must be collected by the TA and stored in a secure location away from students. Acceptable storage includes in a bag, desk, locker, or central location in a classroom or school office.

## ***During Testing***

If an electronic device is found on a student during testing, schools must proceed as follows:

- Confiscate the electronic device.
- Contact the STC, principal, and/or the DTC.
- Check the device for pictures, texts, transmissions by applications (such as Instagram), and any other recent use.
- If possible, run a data recovery program that is compatible with the device’s operating system (commonly Windows, Android, Apple, and Blackberry) to determine recent use of the device.
- Continue testing the student.
- At the completion of a testing session, interview the student regarding use of the device.
- Enforce school/district disciplinary action.
- Fill out Testing Irregularity Reporting Form and submit to the STC.
- Students caught with electronic devices during testing may have assessments invalidated by the PED.

### **2.1.3 Prohibited Activities**

It is unethical and shall be viewed as a violation of test security for any person to

- allow students to share information during the test administration;
- provide assessment accommodations that do not have instructional relevance or are not connected to a specific skill deficit determined by the student’s educational team (**Note:** Text-to-Speech is considered an accessibility feature for the NM-MSSA Mathematics assessment, and an accommodation for the ELA assessment.);
- give special assistance of any kind that could influence students’ responses to test questions;
- direct a student to change responses to test questions or suggest that he or she should;
- allow students access to NM-MSSA questions before testing;
- change a student’s response to a test question;
- photocopy, transcribe, or in any way duplicate any part of the NM-MSSA;
- allow students to have cell phones or electronic devices not medically necessary during test sessions;
- fail to return all used and unused secure test materials;
- review the test questions for any reason;
- discuss the test with students/colleagues during or after the test administration; or
- fail to report any violations of these test administration security measures.



**School and district staff are prohibited from studying or discussing test items in any manner, either among themselves or with students, before, during, or after testing.**

### 2.1.4 Testing Irregularities and Security Breaches

All administrations of the tests are to be conducted under the standardized procedures described in this manual. Testing irregularities, such as potential cheating, and any suspected or actual breach of security should be reported immediately by the TA to the DTC or STC.

**If any certified school employee is involved with any of the unauthorized activities cited in the Security Guidelines section (section 2.1) of this manual, that employee is in jeopardy of possible license revocation by the PED.**

### 2.1.5 Student Confidentiality

The Family Education Rights and Privacy Act (FERPA) requires that access to individual students' information be restricted to the student, their parents/guardians, and authorized school personnel. All superintendents and charter leaders, principals, DTCs, and STCs are responsible for maintaining the privacy and security of all student records.

Individual test scores, as well as all other aspects of a student's record, are confidential. Scores can be released only in instances of school staff needing to know them, valid requests for transcripts, or the student/parent enforcing their right to inspect and request explanations of their records. In some instances, a court order or subpoena may require the release of this information; however, the student/parent must be informed of this request before any information is released. Test scores may also be released to parents or guardians of all students enrolled in a New Mexico public school.

Researchers may obtain test scores from school districts provided the information requested is at the group or cohort level and are discouraged from reporting aggregated data for groups of fewer than ten students.

Those who work with student test scores are required to withhold confidential information unless proper release is granted by the caretaker of student records. School personnel are also charged with maintaining the results of standardized tests as part of student records.

## 2.2 Administration Information

### 2.2.1 Testing Requirements

Participation in state-wide summative testing is required. In 2025, New Mexico will administer the NM-MSSA to all eligible students enrolled in grades 3–8 for subjects English Language Arts, Spanish Language Arts, and/or Mathematics. PED will hold all schools accountable for participation in the NM-MSSA.

Exceptions to the requirement for all students to participate are permitted only in the following circumstances:

- Students who meet the eligibility criteria for alternate assessment should be assigned the Dynamic Learning Maps (DLM) in lieu of the NM-MSSA ELA, SLA, and/or Mathematics.
- Non-Spanish speaking students with a PED-approved medical exemption are not required to participate.
- EL students who are enrolled in U.S. public schools for their first year are exempt from the ELA portion of NM-MSSA. Math with appropriate EL accommodations is still required.
- EL students who are enrolled in U.S. public schools for their first year must participate, with appropriate accommodations provided as needed.
- Foreign exchange students, private school students, homeschooled students, expelled students who have refused educational services, and those students who have withdrawn from the school or district are not required to participate.

## 2.2.2 Test Design and Durations

### *NM-MSSA Question Types*

The NM-MSSA Mathematics assessment is composed of a variety of question types:

- 1-point machine-scored items (MS-1)
- 3-point constructed response items (CR-3)

The NM-MSSA ELA and SLA assessments are composed of the following question types:

- 1-point machine-scored items (MS-1)
- 2-point machine-scored items (MS-2)
- 7-point writing prompts (WP)

For more details on the test specifications, please refer to the test blueprint and test specifications for each subject available in the Help & Support Page at <https://newmexico.onlinehelp.cognia.org/resources-nm-mssa/>.

### *Administration Times*

All test sessions, including make-up testing, must be completed during the test administration window. (Refer to the Important Dates table on the inside front cover of this manual.)

Administration time is the total time that schools should schedule for each test session. It includes the session testing time and the approximate times for administrative tasks such as reading directions, answering questions, and distributing and collecting test materials. See the following table.

#### **Administration Time: Guidelines for Scheduling**

Task	Time to be Allotted for Test Administration
1. Pre-administration tasks, including reading instructions to students and answering questions.	10 minutes
2. Distribution of test materials to students.	5 minutes
3. Administration of session.	Refer to the session testing timetables
4. End-of-session activities, including collecting test materials.	5–15 minutes

### *Testing Times*

The NM-MSSA is an untimed test. Suggested times are provided to assist with scheduling. The suggested testing times for the 2025 assessments are listed in the following table.

## 3. Accessibility Features and Accommodations

### 3.1 Overview and Policies

Accommodations and participation decisions will be made by each student's educational team. The team should have ensured that the student received the agreed-upon, allowable accommodation(s) in daily instruction and classroom assessments in the content area. Unlike accessibility features, the use of each accommodation in daily instruction must have written documentation in the Individualized Education Program (IEP), 504, or EL plan. Only students on IEP, 504, or EL plans are eligible for accommodations. Students who have achieved fluent English proficiency are not eligible for EL accommodations.

For additional PED guidance concerning accommodations on the required summative assessments, refer to the *NMPED Accessibility & Accommodations Manual: Supporting Students During Testing*, available at <https://webnew.ped.state.nm.us/bureaus/assessment/accommodations-manuals/>.

**For PBT administration**, refer to [Appendix G](#) to learn how to handle student paper testing responses.

If typewritten responses to the short-answer and open-ended questions are permitted as an accommodation, follow the instructions in [section 3.3.5](#).

**For CBT administration**, the DTC or STC **must** assign accessibility features and accommodations embedded in the iTester system before the start of testing. TAs cannot perform this task.

Administering a test without IEP-documented accommodations or administering a test with accommodations not documented in the IEP is a testing irregularity that will require an invalidation. TAs should ensure that the appropriate assignment of accommodations is in place prior to the student completing a question on the assessment. Modifications are changes in test administration that interfere with the comparability of scores. Examples of such modifications include giving students test administration directions that are not included in this manual. **Any assessment in which modifications are provided must be invalidated.**

#### ***A Note about Text-to-Speech***

When taking the NM-MSSA ELA or SLA, Text-to-Speech (TTS) is **only** available for Session 2, which covers Language Usage, including Writing Prompts.

TTS is **not** available and should **not** be available for Session 1 of the NM-MSSA ELA or SLA, which covers Reading, where the student is being tested on their ability to read.

It is important to note that when the student is assigned the TTS accommodation on the CBT, the Play button icon will show up in the entire MSSA ELA/SLA test. However, if the Play button is pressed, nothing will play because there is no alternate text assigned for that session.







### 3.2 Requirements for Computer-Based Testing



#### 3.2.1 Setting Accessibility Features and Accommodations

The DTC or STC **must** assign accessibility features and accommodations embedded in the iTester system before the start of testing. TAs cannot perform this task. For example, the Text-to-Speech feature **must** be assigned before scheduling a test and **cannot** be assigned after the student has logged in to any session of any test without delaying your testing schedule. Other accommodations to be delivered locally are also documented in the Portal. Call the New Mexico Help Desk with any questions related to assigning accommodations in the iTester system.

## 3.2.2 Online Portal Accessibility Features and Accommodations Chart

The following accessibility features and accommodations are available to some students.

## 3.3 Requirements for Paper-Based Testing

*Please read these directions carefully before you administer the test.*

### 3.3.1 Test Security

All security measures outlined in this manual are applicable and must be followed when testing with the large-print, braille, and human reader versions of the test. **Duplication or retention of any large-print or braille test material is not permitted.**

### 3.3.2 Administering the Large-Print Version

Students who are administered a large-print version of the NM-MSSA must be given a large-print test material packet. The packet includes a large-print instructions sheet, a large-print test booklet, and a standard-sized test booklet and answer document.

Please consider the following when administering the large-print test:

- Test administrators should read the directions and scripts from the TAM the same way as for a standard administration.
- The large-print test booklet is 11" × 17". It is recommended that these tests be administered to students at tables (perhaps library-sized) to allow for the booklet's size and to ensure student comfort.
- In addition to the materials in the large-print packet, students should also be provided with pencils. The appropriate calculators should be made available for students taking the grades 6–8 Mathematics tests (see [section 2.2.2](#) for details).

#### **Student Responses**

Refer to [Appendix G](#) to learn how to handle student paper testing responses.

If typewritten responses to short-answer and open-ended questions are permitted as an accommodation, follow the instructions in [section 3.3.5](#).

### 3.3.3 Administering the Braille Version

Students who are administered a braille version of the NM-MSSA must be given a braille test material packet. The packet includes a braille instructions sheet, a braille test booklet and associated test administrator notes, a standard test booklet, and a standard answer document, as well as any content-appropriate ancillary materials. Please consider the following when administering the braille test:

- Test administrators should read the directions and scripts from the TAM the same way as for a standard administration. The TAs may make adjustments to the specific directions for administering a test as needed to ensure that students taking the braille version of the test understand the testing procedures. For example, you should tell students they do not need to read or pay attention to the copyright notice that appears in the braille version.
- Various materials (e.g., braille writers, slates and styluses, Cranmer modified abacuses, and word processors without the aid of spelling or grammar checks) may be required by the students and must be furnished before the appropriate subtest. Additionally, the TA should have available braille paper and placeholders.

#### **Student Responses**

If typewritten responses to the short-answer and open-ended questions are permitted as an accommodation, follow the instructions in [section 3.3.5](#).

### 3.3.4 Administering the Human-Reader Version

Students who are administered a human-reader version of the NM-MSSA must be given a human-reader test material packet. The packet includes a human-reader test administrator script, two standard-sized test booklets, and one answer document.

In addition to the materials in the human-reader packet, students should also be provided with pencils. The appropriate calculators should be made available for students taking the Mathematics tests. (See [section 2.2.2](#) for details.)

#### ***Student Responses***

Refer to [Appendix G](#) to learn how to handle student paper testing responses.

If typewritten responses to short-answer and open-ended questions are permitted as an accommodation, follow the instructions in [section 3.3.5](#).

### 3.3.5 Typed Responses for Paper-Based Testing

Typed responses to short-answer and open-ended questions may be submitted for those students who qualify for the Assistive Technology Devices Responses accommodation.

Each page of the typed response must contain the following information:

- Student's first and last name
- Student's state student ID number (which also appears on the student's ID label)
- Unique answer document number found on each page inside the student's answer document
- District name
- School name
- Session name (e.g., ELA Session 1)
- Question number (e.g., #6)

At the end of testing, the TA collects all sheets of paper containing typewritten responses from each student and provides them to the STC and DTC along with the student's answer document. The TA must never staple, tape, or glue typed response pages into an answer document.

Refer to [Appendix G](#) to learn how to handle student paper testing responses.

## 4. Before Computer-Based Testing

### 4.1 Preliminary Preparation

Inform students of the importance of the NM-MSSA and of the testing schedule before testing begins. Be sure that students are familiar and comfortable with standardized test procedures and test-taking strategies. The NM-MSSA practice tests will provide an opportunity for students to become familiar with the types of questions on the assessments and the features and tools available in the online testing platform.

Test administrators should become familiar with all administration procedures before testing.

Carefully read through this manual and the *NMPED Assessment Kiosk User Guide* (available at [newmexico.onlinehelp.cognia.org/cbt-guides](http://newmexico.onlinehelp.cognia.org/cbt-guides)); review the testing schedule established by the district/school; and be sure to gather materials for each session before the start of testing. You should have a list of the students who will be testing in your classroom and their printed Student Login Tickets, as well as a list of students requiring accommodations and the accommodations each student requires. Please review the session scripts that you will read to students during testing (see [sections 6.1–6.6](#)).

### 4.2 Test Scheduling

Plan to administer each test session within the testing window scheduled by your school. Test sessions must be administered in accordance with PED test schedule guidelines. See [section 2.2.2](#) for approximate session administration times.

Breaks of at least 15 minutes should be provided between sessions. Students should be allowed to leave the testing room to use the restroom as needed during the testing session, provided they are escorted to the facility. Before leaving the classroom, the students must give their login tickets and scratch paper to you, or the proctor. While the student is in the restroom, ensure that the remaining students are supervised and login tickets and scratch paper do not leave the classroom.

When students complete all the sessions scheduled for the day, collect their used scratch paper and instruct the students to sit quietly or quietly read a book at their desks until all students have finished. Reading is the only activity allowed. Test administrators should not activate any other session of the test at this time.

In the event that a single student or a small group of students does not complete the assessment as quickly as a large majority of the class, it is permissible for a TA to quietly dismiss the class or take the remaining testers to a different location to complete the session.

#### 4.2.1 Testing Disruptions

The schedule should provide sufficient time to ensure that each test session will be completed before lunch or afternoon dismissal. If it is estimated that students cannot finish a session before dismissal, the students should not begin the session and the session should be rescheduled for a makeup day.

Except in the following circumstances, students are not allowed to stop in the middle of a session and resume at a later point:

- Sudden student illness
- Emergency evacuation
- Fire drill

In these circumstances, students are allowed to resume the session when they return to school. An irregularity report should be filed, but an invalidation is usually not warranted provided that the student is not allowed to revise responses provided before the disruption.



## 4.2.2 Absences

Parents and guardians should be urged in advance of testing to avoid making medical appointments or planning trips for their child on a scheduled testing day. If a student is unable to take a test session(s) on the scheduled testing day(s) due to illness, a medical appointment that cannot be rescheduled, or unforeseen circumstances, the student may be administered the test session(s) that was missed on a makeup testing day.

In the event that a student misses one session, there is no reason to prevent them from taking the next. Test sessions should be, but do not have to be, administered in numerical order.

As a TA, you must keep a record of all student absences for each session of the regular and makeup NM-MSSA sessions that you administer and then forward this record to the STC. In turn, the STC must keep a record of all students who miss both the regular and makeup administrations of any test session.

## 4.2.3 Makeup Testing

If a student misses a session due to illness or some other legitimate reason, a makeup session must be held before the end of the testing window. Makeup tests may be administered throughout the main testing window except during regular testing. Makeup tests are considered valid so schools and districts are not penalized for legitimate student absences.

# 4.3 Preparing for Administration

## 4.3.1 Preparing the Testing Environment

Prepare the testing room by ensuring the following:

- Student workstations are ready for testing; this includes making sure computers or laptops are fully charged.
- Computer monitors are positioned to prevent students from seeing each other's work.
- You have obtained scratch paper and pencils for each student you will be testing.
- You have obtained or printed Session Access Codes.
- You have obtained or printed Student Login Tickets for each student assigned to you for testing.
- The room has adequate lighting.
- The room has a "Testing—Do Not Disturb" sign on the door.
- Nothing is visible that would give clues to any of the answers on the test, such as rubrics, writing guides, word walls, hundreds charts, fact tables, etc.

If you have questions about student computers, see your technology coordinator. If you have questions about Student Login Tickets or any other facet of administering the tests, see the STC or DTC, or refer to selections from the suite of training materials available at [newmexico.onlinehelp.cognia.org](http://newmexico.onlinehelp.cognia.org).

Students may use scratch paper on any session of the NM-MSSA. All used scratch paper must be collected and securely destroyed at the testing location.

## 4.3.2 Materials Required, Permitted, and Not Permitted

The following materials are required for computer-based testing:

- this manual, which includes English and Spanish administration scripts
- a "Testing—Do Not Disturb" sign for the classroom door
- scratch paper
- two pencils with erasers for each student
- student login tickets

## ***Calculators***

For the NM-MSSA Mathematics assessments where calculators are used (see the tables in [section 2.2.2](#)), the appropriate calculator will be available on the online platform. Additionally, students may use hand-held calculators (provided by either the school or the student) as allowed by local policy.

- For grades 3–6, students may use only four-function calculators with square root and percentage functions for all calculator sections.
- For grades 7 & 8, students may use only scientific calculators for all calculator sections.

For information on allowable calculator use and specifications, refer to the NM-MSSA Calculator Policy ([Appendix E](#)).

## ***Mathematics Formula Sheets or Reference Sheets***

The NM-MSSA Mathematics assessments do not require any formula sheets or math reference sheets. Please note the following considerations that go into the decision to not providing formula sheets and reference sheets for the NM-MSSA:

- The language of the standards offers general guidance as to when students are expected to “know” formulas versus “apply” formulas.
- All of the items on the NM-MSSA Mathematics assessments have been thoroughly reviewed by grade-level mathematics educators and deemed appropriate for their respective grade level.
- To properly assess the applicable standards, some items are written so that students will need to know the formulas to answer the question, whereas other items are written so that knowledge of the formula is not being assessed, and thus the formulas may be provided within the item.
- In the same vein, some items are written so that students will need to know grade-level appropriate conversions between units, whereas some items provide the conversion to the student.
- This flexibility around the inclusion of formulas and conversion units allows for a variety of assessment items to better assess different aspects of the relevant standards.

### 4.3.3 Session Access Codes

DTCs or STCs schedule tests via the Test Sessions tab. Please check with your DTC or STC for your local policies and procedures for obtaining Session Access Codes.

In some schools, after the test has been scheduled, TAs may go to the “View Details/Student Logins” page for the applicable class scheduled for the test. On this page the TA will see access codes for each session of the test.





### 4.3.4 Online Portal Universal Tools and Navigation Features

The following tools and navigation buttons are available to all students.

Navigation/ Universal Tool	Icon	Description/Action
<b>Answer Eliminator</b>	 	<p>The Answer Eliminator tool allows students to eliminate response option(s) by placing a strike through over the option. Students must click on the icon in the tool bar to activate the eliminator, and then click on the response options they wish to eliminate.</p> <p>To select a response option as their answer choice, the answer eliminator tool must be turned off before selecting the response option.</p> <p>Options that have been eliminated cannot be selected as an answer choice. To undo an eliminated response option, the student must turn on the answer eliminator, deselect the option, then turn off the answer eliminator tool and select their answer choice.</p>
<b>Back/Regresar Button</b>		Click the “Back” button to move to the previous test question.
<b>Bookmark</b>		Bookmark or save items to come back to later by clicking the star icon. The Jump to Question icon is a picture of a down arrow. Click the down arrow to be taken to a test review screen to jump to another test question.
<b>Clear/Borrar Button</b>		Click the “Clear” button to clear an entire answer from the screen.
<b>Constructed Responses Writing Tools (rich text editor response option)</b>		Both open-ended and short answer constructed response items will also have a series of writing tools that are shown with the symbols for undo, redo, bold, italicize, underline, bullet list, numbered list, increase indent, decrease indent, and spell checker. The spell checker is disabled for ELA and SLA assessments.
<b>Finish/Terminar Button</b>		Click the “Finish” button to submit your test; the “Finish” button is only active on the last item of the session.
<b>Line Reader</b>		The line reader can be used to assist in reading by raising and lowering the tool for each line of text onscreen. It is resizable and draggable.
<b>Calculator</b>		The Calculator may be used to help answer questions during Session 2 of the NM-MSSA Mathematics tests.
<b>Notepad</b>		Use the Notepad tool to type notes in the Notepad for each separate test question. Notes on a stimulus are viewable for all items pertaining to that stimulus. The Notepad can be moved around on the screen and resized as desired.
<b>Pause and Inactivity Timeout Button</b>		This button allows the student to exit the test (log out and close the kiosk) or pause the test, in which case they will have a timer that will allow them to re-enter the test from the pause timer screen using only their password if they return in less than 60 minutes.

Navigation/ Universal Tool	Icon	Description/Action
<b>Pop-Up Glossary</b>		Students can view definitions of pre-selected words by selecting words with a book icon to launch a pop-up screen with the word's definition.
<b>Sketch</b>		Use the Sketch tool to sketch, highlight, or underline text on the screen. This tool will only appear on items that do not have a sketchpad widget or rich text editor response option.
<b>Text Highlight</b>		Use the Text Highlight tool to select text and highlight the selection.
<b>Turn In/Entregar Button</b>		Once students have answered all questions and reviewed their responses on the test item review page, they must click the "Turn In" button and then confirm by clicking on the "Turn In" button again to turn in their test. The test status in the Portal will then show "Finished," and the student will not be able to log into that test again.
<b>Zoom View (magnifier)</b>		Students can magnify the entire screen in four increments: 100%, 150%, 200%, and 300%.

## 5. During Computer-Based Testing

### 5.1 Directions for Test Administration

In sections 6.1–6.6, the directions that are to be read aloud to students are in **bold** font. Directions to you are interspersed within the script and are in regular font and in brackets. Read the directions for students exactly as written, using a natural tone and manner. If you make a mistake in reading a direction, stop and say, “No. That is wrong. Listen again.” Then read the direction or question again.

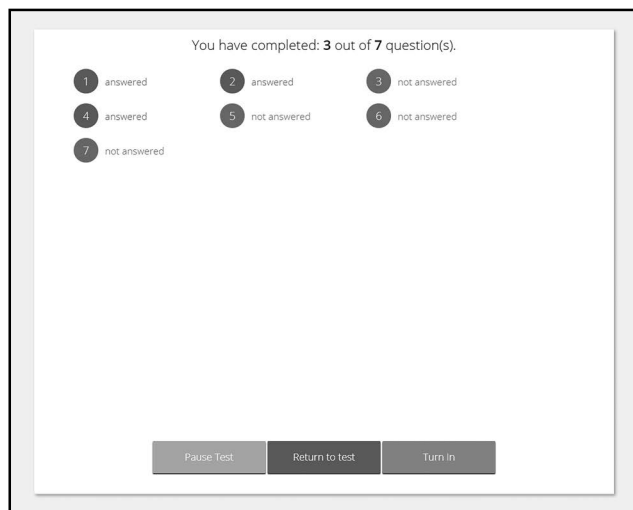
- Encourage the students to do their best.
- Check periodically to make sure that the students are recording their answers properly.
- Ensure that the students work until they reach the end of each testing session.
- Remember that you are prohibited from spelling words for students during all testing sessions.

### 5.2 Monitoring Test Sessions

At the beginning of each session of the test, walk around the room to check that students are logged in correctly. TAs are expected to walk around the room and actively monitor students. During each test session, ensure they are working appropriately by clicking to the next item when necessary, typing or drawing their answers in the appropriate answer boxes, and not spending too much time on any one item. If you have a concern or are unsure how to proceed, please contact the STC.

#### IMPORTANT REMINDERS FOR TEST ADMINISTRATORS:

You may not help students in any way, except during the general instructions or as specified in this manual. **You may assist a student if a technology issue occurs.** Under no circumstances are students to be prompted to revise, edit, or complete any test questions during or after testing.



Test administrators may not view student responses.

Once a student has reached the test map page that shows which items have been answered, unanswered, marked with a star bookmark for review, or skipped, instruct the student to ensure all items have been answered and to review any bookmarked items. When the student is ready to turn in their test, the student must return to the test map page by clicking on the item number/down arrow in the upper right hand corner of the test interface. then the student will click on the “Turn in” (“Entregar”) button and confirm by clicking the “Turn in” button again.

Once a test is turned in, have the students click “Exit” in the upper-right corner before allowing the student to sit quietly and/or read a book at their desk.

If you encounter a technology problem during testing please call the Cognia Help Desk at 877-676-6722. Please be prepared to answer the following questions along with a description of the issue:

1. Is there an error message? If yes, what is the error message?
2. Is it affecting more than one student? If yes, how many?

3. What is the Operating system and version of the device experiencing the issue (for example, Windows 10, Chrome 85, MacOS 10.15)?

**Note:** While restarting the student's test device may immediately resolve the issue, we recommend contacting the Help Desk before restarting the device. The Help Desk may be able to provide guidance that will prevent the issue from reoccurring during another student's test.

## 6. NM-MSSA CBT Directions and Scripts

### 6.1 NM-MSSA CBT—Mathematics & ELA (English) Session 1

**Suggested Session Time:** Refer to the tables in [section 2.2.2](#).

**Materials Required:** Student Login Tickets, sharpened pencils with erasers, and scratch paper; refer to [section 4.3.2](#) for other materials that may be permitted.

On the day(s) of the NM-MSSA testing, be sure to prepare the testing space as described in [section 4.3.1](#).

**Note:** Reference/formula sheets are not needed for Mathematics tests.

**SAY** **You are not allowed to have a cell phone or other electronic device during testing.**  
[Please refer to PED Policy on Electronic Devices in [section 2.1.2](#).] **If you have a cell phone or an electronic device in your possession, turn it off now and raise your hand.** [Collect and store students' devices according to the procedure at your school.]

**SAY** **If a cell phone or other electronic device is discovered during testing, it will be confiscated and subject to search.**

**Make sure your computer is turned on. Do not open any other programs.** [If necessary, wait for workstations to boot up.]

**SAY** **Now double-click the “New Mexico Public Education Department Assessments” icon on your desktop. Once the program opens, you will see a student login page.**

Wait for everyone to have the student sign-in page displaying on their screens. Work with students who need extra help accessing the portal. Remember, no other programs should be running while the testing kiosk is being launched.

**SAY** **Each of you should see the student sign-in page on your screen. Raise your hand if you do not see the sign-in page.**

Work with students who need extra help accessing the sign-in page. Remember, no other programs should be running while the students are launching the kiosk.

Distribute the Student Login Tickets. Post the Session 1 Access Code at the front of the room.

**SAY** **You have been given a test ticket with your name and test login information. Check the ticket to be sure you have your own. If someone else's name is on the ticket, raise your hand.**

If any students have the wrong ticket, make the correction.

**SAY** **Carefully type the username and password in the sign-in screen exactly as it appears on the ticket. Then click the *Sign In* button. Keep your login ticket on your desk. It will be collected at the end of this test.**



If you have successfully logged in, you will see the word “Hello” followed by your name. Verify that your name, student testing ID number, and date of birth are correct. If the information on the screen is not correct, raise your hand.

Another way to navigate through the form is by using the Test Map. You can access the Test Map by clicking the down arrow next to the question number at the top left of the screen. Click this arrow now.

The Test Map is a visual representation of all of the questions on the test. Answered questions will appear blue; questions you have viewed, but not answered are red; bookmarked questions have a yellow star next to them; and questions that have not been visited are gray. (Notice that you have a bookmarked question.) Clicking a question number will take you directly to that question on the test. You can pause the test, return to the test, or turn in your test from the Test Map.

Click the first question number on your test map. You are now back to the first question in Session 1. Click the bookmark star to remove the bookmark.

In the lower-left corner is your toolbox. There you will see several tools available to use on this test.



The Answer Eliminator tool looks like lines with an X over them. This tool allows you to put a red X through answer choices on multiple choice items. Click the tool to enable it. Then click answer choice "A." A red X will appear over the answer choice, and you will not be able to select it as the correct answer. If you change your mind, you can remove the red X by clicking it. Click answer choice "A" now to remove the red X. When you are ready to select the correct answer, you must first click the Answer Eliminator tool in the toolbar to disable it. Click the tool now.



The Notepad tool looks like a pencil and a pad of paper. You can use the Notepad tool to make notes, plan your response, or work out questions. You can also copy and paste from the Notepad into the constructed-response answer space. Notes typed in the Notepad tool will NOT be saved or scored, so you must type your answer in the designated answer space.

Click the Notepad tool now. You can move the Notepad by clicking in the dark band at the bottom and dragging to the new location. You can also resize the Notepad by clicking the right corner of the band and dragging out or in. Click the "X" in the upper-right corner of the Notepad tool to close it.



The Line Reader tool has the letters "abc." This tool provides a small window that you can move up and down the page to cover some of the words to help with reading.



The Sketch tool looks like a pencil. Clicking on it will open a toolbox containing several colored pencils, an eraser, and a highlighter. Use this tool to highlight parts of the passage or question that you want to stand out. Do not use it to write your answers. Click this tool now.



Now, click the yellow highlighter and highlight a word in the item. Now click the blue pencil and circle a word in the item. You can erase the marks you just made by clicking the eraser and then clicking the mark. Click the "X" in the upper right corner of the tool to close the Sketch tool.



The Text Highlight tool looks like a highlighter. This tool will allow you to select specific words you want to highlight.



From the pop-up menu, you can choose to highlight text or use the eraser to remove some or all of the highlighted text.

In addition to these tools, some words on the test may have a small book next to them. You can click on the book to open a pop-up glossary that will provide you with the definition of the word.

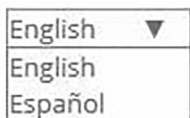

## 7. After Computer-Based Testing

### 7.1 Final Reminders

2. All used scratch paper and student login tickets must be collected and securely shredded at the school immediately following testing.

## 8. Before Paper-Based Testing

### 8.1 Preliminary Preparation

Inform students of the importance of the NM-MSSA and of the testing schedule before testing begins. Be sure that students are familiar and comfortable with standardized test procedures and test-taking strategies.

Test administrators should become familiar with all administration procedures before testing.

Carefully read through this manual, review the testing schedule established by the district/school, and be sure to gather materials for each session before the start of testing. You should have a list of the students who will be testing in your classroom, as well as a list of students requiring accommodations and the accommodations each student requires. Please review the session scripts that you will read to students during testing (see [sections 10.1–10.6](#)).

### 8.2 Test Scheduling

Plan to administer each test session within the testing window scheduled by your school. Test sessions must be administered in accordance with PED test schedule guidelines. See [section 2.2.2](#) for approximate session administration times.

Breaks of at least 15 minutes should be provided between sessions. Students should be allowed to leave the testing room to use the restroom as needed during the testing session, provided they are escorted to the facility. Before leaving the classroom, students must give their test booklets with inserted answer documents and all other test materials to you or the proctor. While the student is in the restroom, ensure that the remaining students are supervised and the test materials do not leave the classroom.

When students complete all the sessions scheduled for the day, collect their test booklets with inserted answer documents and instruct the students to sit quietly or quietly read a book at their desks until all students have finished. Reading is the only activity allowed.

#### 8.2.1 Testing Disruptions

The schedule should provide sufficient time to ensure that each test session will be completed before lunch or afternoon dismissal. If it is estimated that students cannot finish a session before dismissal, the students should not begin the session and the session should be rescheduled for a makeup day.

Except in the following circumstances, students are not allowed to stop in the middle of a session and resume at a later point.

- Sudden student illness
- Emergency evacuation
- Fire drill

In these circumstances, students may be allowed to complete the session later, but they **may not** change responses to any test questions already answered.

#### 8.2.2 Absences

Parents and guardians should be urged in advance of testing to avoid making medical appointments or planning trips for their child on a scheduled testing day. If a student is unable to take a test session(s) on the scheduled testing day(s) due to illness, a medical appointment that cannot be rescheduled, or unforeseen circumstances, the student may be administered the test session(s) that was missed on a makeup testing day.

As a TA, you must keep a record of all student absences for each session of the regular and makeup NM-MSSA sessions that you administer and then forward this record to the STC. In turn, the STC must keep a record of all students who miss both the regular and makeup administrations of any test session.

### 8.2.3 Makeup Testing

If a student misses a session due to illness or some other legitimate reason, a makeup session must be held before the end of the testing window. Makeup tests may be administered throughout the main testing window except during regular testing. Makeup tests are considered valid so schools and districts are not penalized for legitimate student absences.

## 8.3 Preparing for Administration

### 8.3.1 Preparing the Testing Environment

Prepare the testing room by ensuring the following:

- There is sufficient lighting and space between students' desks.
- The room has a "Testing—Do Not Disturb" sign on the door.
- Nothing is visible that would give clues to any of the answers on the test, such as rubrics, writing guides, word walls, hundreds charts, fact tables, etc.

### 8.3.2 Materials Required, Permitted, and Not Permitted

The following materials are **required** for paper-based testing:

- this manual, which includes English and Spanish administration scripts
- a "Testing—Do Not Disturb" sign for the classroom door
- two pencils with erasers for each student
- test booklets
- answer documents
  - › **Note:** for grade 3 tests, the answer bubbles are integrated into the test booklets; there are no separate answer documents
- for the Mathematics tests
  - › calculators for Session 2 (see *Calculators* below)

The following materials are **permitted** (but not required) for paper-based testing:

- highlighters
  - › Students may use yellow highlighters to mark in the test booklets.
- scratch paper

#### **Calculators**

For the second session of Mathematics assessments (see the tables in [section 2.2.2](#)), a hand-held calculator should be provided to each student.

- For grades 3–6, students may use only four-function calculators with square root and percentage functions during Session 2. The use of calculators is not allowed during Session 1.
- For grades 7 & 8, students may use only scientific calculators during Session 2. The use of calculators is not allowed during Session 1.

## 9. During Paper-Based Testing

### 9.1 Directions for Test Administration

In sections 10.1–10.6, the directions that are to be read aloud to students are in **bold** font. Directions to you are interspersed within the script and are in regular font and in brackets. Read the directions for students exactly as written, using a natural tone and manner. If you make a mistake in reading a direction, stop and say, “No. That is wrong. Listen again.” Then read the direction again.

- Encourage the students to do their best.
- Check periodically to make sure that the students are recording their answers properly and are only working in the current test session.
- Ensure that the students work until they reach the end of each testing session.
- Remember that you are prohibited from spelling words for students during all testing sessions.

#### ***Handling the Student’s Completed Answer Document***

- There will be no return of paper test materials back to Cognia.
- All paper testing students’ responses must be entered into the portal.
- Per NMPED instructions, LEAs are to keep their used test materials (such as the answer documents with the student responses in a secure location).
- Please refer to NMPED’s policy changes for NM-MSSA paper-based testing in Appendix G

[Please refer to PED Policy on Electronic Devices in [section 2.1.2](#).] **If you have a cell phone or an electronic device in your possession, turn it off now and raise your hand.** [Collect and store students' devices according to the procedure at your school.]

**SAY If a cell phone or other electronic device is discovered during testing, it will be confiscated and subject to search.**

- ➡ [If administering a grade 3 test, say] **I will now give you your test booklet. Leave it closed until I tell you what to do.**
- ➡ [If administering a grades 4–8 test, say] **I will now give you your test booklet and answer document. Leave both closed until I tell you what to do.**

[Distribute the test booklets, answer documents (for grades 4–8), and two pencils to each student.]

**SAY Only pencils may be used.**

- ➡ [If administering a grade 3 test, say] **Look at the name box on the front cover of your test booklet.**
- ➡ [If administering a grades 4–8 test, say] **Look at the name box on the front cover of your answer document.**

**Print your first and last name neatly on the line.** [Pause.]

**SAY Open your test booklet to the Session 1 directions.**

- ➡ [If administering a grades 4–8 test, say] **Open your answer document to the first page that says "Session 1." Do not fold your answer document back during this test.**

[Walk around the room to make sure everyone has the booklets open to the correct pages. For grades 4–8, answer documents should be open flat, not folded back.]

**SAY** In this session, some questions will have specific directions explaining how to answer. For some questions, you may need to choose more than one correct answer. You will answer other questions by writing your answers in the boxes provided in your test booklet. Be sure to fit your answers within the boxes. Some questions have two or more parts. Be sure to answer all parts. While you are working, be sure to erase completely any changes that you make and clearly fill in the bubble for your intended answer.

**Look at the directions in the test booklet at the top of the page. Follow along as I read them aloud.**

**If you do not know the answer to a question, you may go on to the next question.**

**If you finish early, you may review your answers and any questions you did not answer in this session ONLY. Do not go past the stop sign. Are there any questions?** [If there are any procedural questions, reread the directions.]

Place all test materials in central, secure, and locked storage until the next testing session.

## 10.2 NM-MSSA PBT—Mathematics (English) Session 2

**Suggested Session Time:** Refer to the tables in [section 2.2.2](#).

**Materials Required:**

- test booklets, answer documents (for grades 4–8), sharpened pencils with erasers, scratch paper
- calculators (grades 3–6, basic; grades 7 & 8, scientific)

On the day(s) of the NM-MSSA testing, be sure to prepare the testing space as described in [section 8.3.1](#).

**Note:** Reference/formula sheets are not needed for Mathematics tests.

If you are not immediately continuing from the prior session,

**SAY You are not allowed to have a cell phone or other electronic device during testing.**

[Please refer to PED Policy on Electronic Devices in [section 2.1.2](#).] **If you have a cell phone or an electronic device in your possession, turn it off now and raise your hand.** [Collect and store students' devices according to the procedure at your school.]

**SAY If a cell phone or other electronic device is discovered during testing, it will be confiscated and subject to search.**

➡ [If administering a grade 3 test, say] **I will now give you your test booklet. Leave it closed until I tell you what to do.**

➡ [If administering a grades 4–8 test, say] **I will now give you your test booklet and answer document. Leave both closed until I tell you what to do.**

**I will also give you a calculator if you did not bring your own.**

[Distribute the test booklets, answer documents (for grades 4–8), and two pencils to each student. Also distribute calculators to students who did not bring their own.]

**SAY Only pencils may be used.**

To all students,

**SAY Open your test booklet to the directions for Session 2.**

➡ [If administering a grades 4–8 test, say] **Open your answer document to the first page that says "Session 2." Do not fold your answer document back during this test.**

[Walk around the room to make sure everyone has the booklets open to the correct pages. For grades 4–8, answer documents should be open flat, not folded back.]

**SAY In this session, some questions will have specific directions explaining how to answer. For some questions, you may need to choose more than one correct answer. You will answer other questions by writing your answers in the boxes provided in your test booklet. Be sure to fit your answers within the boxes. Some questions have two or more parts. **SAY** **Si se les encuentra un teléfono celular u otro aparato electrónico durante la prueba, les será confiscado y se revisará su contenido.**

➡ [If administering a grade 3 test, say] **Ahora voy a entregarles su folleto de prueba. Déjenlo cerrado hasta que yo les diga lo que van a hacer.**

➡ [If administering a grades 4–8 test, say] **Ahora voy a entregarles su folleto de prueba y su documento de respuestas. Manténganlos cerrados hasta que yo les diga lo que van a hacer.**

[Distribute the test booklets, answer documents (for grades 4–8), scratch paper, and two pencils to each student.]

**Algunas de las preguntas pueden parecer diferentes de las preguntas que has visto antes y es posible que algunas preguntas se refieran a información nueva para ti, pero es importante que contestes lo mejor que puedas.**

**Aun si no estás seguro de la respuesta a una pregunta, debes tratar de responderla.**

**No hagan marcas con el lápiz fuera de los círculos. Si necesitan cambiar una respuesta, asegúrense de borrar su primera respuesta por completo. ## 11. After Paper-Based Testing - NEW FOR 2025

Beginning in 2025, student responses recorded in the paper-based materials (standard, large print, or braille), including multiple-choice and constructed-response items, **MUST** be entered into the iTester online student testing platform to be submitted for scoring and reporting. Student PBT materials must be securely stored until the student responses are recorded and submitted in the iTester Portal. Paper-based materials are not returned to Cognia, as it was done in the past, and must be securely destroyed. Refer to [Appendix G](#) for more details on this process.

	If a student needs to leave the test room for any reason, be sure an escort is available to accompany the student to and from the test room.

## Appendix D: Submitting a Test Offline



### ***What happened and why did my student receive this message?***

Internet connectivity was lost after the student began testing and was not restored by the time the student completed the test. The student completed the test session and clicked "Turn in Test." The student's responses will be saved to the local folder configured when the NM Summative Assessment Kiosk was initially installed.

### ***What do I do next?***

1. Read the instruction in the message and click *Send Responses*, you will be notified to wait 10 seconds to allow time for the kiosk to check for an internet connection. If internet connectivity was reestablished before clicking *Send Responses*, the stored responses on this device will be sent to the servers and the kiosk will submit and exit the test. If there is no internet connection, the *Send Response* button will show up again. From here you can try to establish internet connection and click *Send Responses* again or move on to step 2.
2. Enter the proctor password to acknowledge that you have read and understand the instructions.
3. Select *Accept and Exit Test*.
4. Reestablish the device's connection to the internet as soon as possible.
5. Relaunch the NM Summative Assessment Kiosk from the same device that received the initial error. Student responses will be automatically sent as soon as the NM Summative Assessment Kiosk is relaunched and the NM Summative Assessment Kiosk will be available for another student's test.

### Paper-Based Test (PBT)

Students in grades 3–5 who are taking the PBT can use a school provided or personal four-function calculator with a square root key during Session 2. Students in grade 6 who are taking the PBT can use their own four-function calculator with a square root key during Session 2. *This is a change from previous years.* Students in grades 7–8 who are taking the PBT can use their own scientific calculator during Session 2. The memory on any hand-held calculator **must be cleared** before the test begins.

### Computer-Based Test (CBT)

A calculator is available online in the eMetric platform. Students in grades 3–5 who are taking the CBT can use a school provided or personal four-function calculator with a square root key during Session 2. Students in grade 6 who are taking the CBT can use a school provided or personal four-function calculator with a square root key during Session 2. *This is a change from previous years.* Students in grades 7–8 who are taking the CBT can use a school provided or personal scientific calculator during Session 2. The memory on any hand-held calculator **must be cleared** before the test begins. You can clear the memory on the TI-30XS by:

#### Reset the TI-30XS MultiView

- You can ensure that everyone starts at the same point by having students reset the calculator: Press **on** and **clear** simultaneously or press **[2nd] [reset]** and then select **2 (Yes)**.

# Handling Spring 2025 NM-MSSA Students' Paper Testing Responses

Starting with spring 2025 NM-MSSA, the NMPED has decided to have no paper test materials (that includes standard print, large print, braille and human reader kits for all subject) returned back to Cognia; instead, the LEA's or District Test Coordinators (DTC) will take care of destroying secure testing materials locally. This, by extension, means that there is no UPS pickup of any paper test materials.

In addition, if the student has an accommodation to take a paper test, the DTC will ensure the student's responses are transcribed into the online portal. The following sections detail what the changes are and how to scribe the students' responses onto the online portal.

### 2025 Changes for NM-MSSA Paper Testing

- Paper test materials and student responses will no longer be returned to Cognia
- No pre-ID labels or rosters will be provided for paper accommodated test forms
- Paper testing student responses will be **scribed** into the iTester portal by authorized LEA staff for scoring and reporting
- Paper test materials will be retained or destroyed by the LEA based on PED policy
- UPS Return Service Labels and Return Envelopes will not be provided as No UPS pickup will be necessary

### NMPED Policy Changes for MSSA Paper-Based Testing

- Two staff members will be required to input and verify students' responses as they are entered into the NMPED Assessments Portal.
- Staff members must be qualified to serve as Test Administrators.
- Both staff members must sign the NM-MSSA Paper-Based Testing Verification Agreement for each student.
- Secure test materials must be retained for five years.
- For Grade 3 standard print and Large Print, the *Verification Form* will be stapled to the integrated test booklet and answer document (since there is no separate answer sheet), and these integrated booklets must be retained.
- For Grades 4-8, all subjects, standard print, large print and braille, the *Verification Form* will be stapled to the respective answer sheet, and the answer sheets must be retained. The test booklets will need to be destroyed locally and securely by each LEA.
- For human reader kits, large print kits, and braille kits, all grades, only the student's answer documents or integrated test booklets for grade 3 will need to be retained following the same procedures outlined above. The remainder of the kit contents will be destroyed securely locally.

## Scribing NM-MSSA Paper Testing Student Responses

- Students taking a Paper Based Test will be added to the eMetric testing system along with all other students.
- Students taking a Paper Based Test **must be assigned the Human Scribe accommodation prior to creating the test session** on the Accommodations Tab of the Student information section.
  - If the Human Scribe accommodation is not assigned **PRIOR** to creating the test session, the student's online form **WILL NOT** match the student's paper test.

- The scribe will log into the iTester system as the student using the student's username and password
- The scribe will enter the student responses exactly as they appear in the student's test booklet or answer document
- The scribe will submit the test as the student
- The DTC/STC will retain the student responses per PED policy and destroy all other secure materials
